Honoring the unique legacy that is Northminster, the Legacy Giving Ministry stewards four funds:

Northminster Fund

The Northminster Fund receives both present and legacy gifts, restricted and unrestricted, to support the mission of the Legacy Giving Ministry.

Campus Fund

The Campus Fund receives legacy gifts to create and/or maintain the grounds and facilities of Northminster for purposes of worship, fellowship and service.

Missions Fund
